Potomac River Fisheries Commission Commercial License Application Instructions

Commercial License Registration Fee – All persons must pay the Commercial License Registration Fee prior to the purchase of any commercial license(s) on or after July 1st of each year.

Notice to Renewal Licensees - By making this application for renewal you are certifying to the PRFC that you have filed all catch reports and you have removed all stakes and poles, if any, from the licensed location.

Suspension or Revocation of License (Regulation I, Section 4) - If your commercial fish, crab, or oyster licenses are currently revoked or suspended in either Maryland or Virginia, you will need to attend a hearing before any new licenses can be issued. To schedule a hearing, you must complete an application to be heard at least 20 days before the next regularly scheduled Commission meeting. During the hearing, the Commission will review the details of your revocation or suspension to decide if they will issue a PRFC commercial license to you. If you miss the application deadline, your hearing will be postponed to a future Commission meeting.

Limited Entry Fishery - Types of licenses marked with (LE) are limited entry fisheries and are available as renewals only. If you did not have that type of license last year, please call PRFC office before applying for a new license. Any limited entry licenses NOT renewed on or before the last business day of January, may be renewed only upon the payment of twice the license fee or \$100, whichever is greater, in addition to the published fees, on or before the last business day of April. (Reg. I, Sec. 1(c))

Pound Net = \$250/stand + license fee

Gill Net = \$80/stand + license fee

Hook & Line = \$130/license + license fee

Crab Pot (300) = \$270 + license fee

Crab Pot (400) = \$400 + license fee

Crab Pot (500) = \$530 + license fee

1Striped Bass Tags - The Commission is requiring ALL striped bass tags to be picked up at our office during normal business hours. Monday – Friday, 8:30 a.m. to 4:30 p.m. The Commission eliminated the option of having striped bass tags mailed. If you will designate someone else to pick up your striped bass tags, you will need to use the "Designee Form" to let us know who will pick up your striped bass tags. Without this form, we cannot release your striped bass tags to anyone other than yourself.

Crab Licenses - Crab pot licenses are for the vessel. No more than one license per vessel. There are no restrictions as to the number of people allowed aboard while crabbing pots. You cannot increase the number of pots, but you may decrease them and pay the lower fee.

²Crab Pot ID Tags/Decals – The fee for the crab pot ID tags/decals shall be paid at the time of the crab pot license renewal/issue. Unless you let the PRFC know **prior to** July 1 of each year, you will receive the product that you had for the previous season.
