EMERGENCY ORDER#2016-06

OPENING of MIDDLE POTOMAC OYSTER BARS to the USE of HAND SCRAPES

THE POTOMAC RIVER FISHERIES COMMISSION, having recognized the closure of several lower river oyster bars during the 2015-2016 season has resulted in economic impacts and hardship to the commercial oyster industry, and having found a desire to address those economic impacts and hardships, and finding an urgency to implement mitigative measures, and pursuant to its authority under Regulation I, Section 7(a), as delineated in the attached Schedule A; HEREBY DECLARES AND ORDERS: the following oyster bars open for the use of taking or catching or attempting to take or catch oysters with hand scrapes:

- a) Swan Point, Yellow Banks and Natural Oyster Bar;
- b) Beacon Bar;
- c) Horseshoe and Popes Creek Bars,

AND, IT IS FURTHER DECLARED AND ORDERED: this Order #2016-06 shall become effective February 18, 2016, and remain in effect through March 31, 2016.
