To qualify for a PRFC Registered Buyer license, the applicant must be a certified dealer or working on behalf of a certified dealer on the Interstate Certified Shellfish Shippers List (ICSSL). If you are not on the current list, you will be required to provide us a copy of your certification provided to you by the FDA.				

Commercial License Registration Fee – All persons must pay the Commercial License Registration Fee prior to the purchase of any commercial license(s) on or after July 1st of each year.

Suspension or Revocation of License (Regulation I, Section 4) - If your commercial fish, crab, or oyster licenses are currently revoked or suspended in either Maryland or Virginia, you will need to attend a hearing before any new licenses can be issued. To schedule a hearing, you must complete an application to be heard at least 20 days before the next regularly scheduled Commission meeting. During the hearing, the Commission will review the details of your revocation or suspension to decide if they will issue a PRFC commercial license to you. If you miss the application deadline, your hearing will be postponed to a future Commission meeting.

All oysters harvested from a Potomac River oyster bar **MUST** be sold to a PRFC licensed registered buyer who will then keep a daily accounting of how many bushels were purchased, the name of the harvester, the HS or OT number, and bar name, and that all oysters bushels are tagged appropriately when received. The registered buyer shall also ensure delivery of the harvester's copy of the buyer ticket as soon as possible for their records.
